

REQUIREMENTS FOR L'ANNÉE SOCIOLOGIQUE SUBMISSION GUIDELINES

Original, not previously published papers will be considered. In addition, manuscripts submitted, or substantially similar version of them, should not be under simultaneous consideration for publication by another journal, nor have been accepted elsewhere.

The full articles (including footnotes, list of references, tables and graphs) will not exceed 8000 words (including spaces and punctuation marks) in length. Book reviews will not exceed 1900 words.

All articles submitted should include (1) an abstract, in French and English, as close to 100 words as possible, (2) keywords (a maximum of 10) for the article, (3) a short biographical note on contributor(s) (of a maximum of 800 characters)

Articles may be submitted in French or in English but will not be translated by the editors or their associates.

Upon acceptance of a manuscript, the author will be sent a form concerning the copyright (in all media). Before any article or book review can be published a dated and signed copy of the form must be returned to the Journal office.

SUBMISSION OF PAPERS

Authors are required to submit manuscripts as a Microsoft Word or RTF

PREPARATION OF MANUSCRIPTS

A cover page should carry the title of the article, the name of each author and his or her institutional affiliation as well as contact information for each author (telephone, e-mail addresses, and mailing addresses)

The authors will indicate the complete title of their article (in French and in English) and will propose an abbreviated title.

Contributions text should be double-spaced, The typeface will be Times at a font of 12 points.

Use capital letters and bold or italic font for material that is to be set in capital letter, italics or bold in the printed paper. The location of tables, figures and graphs in the text should be indicated. They should also be numbered consecutively. Graphs must be in camera-ready copy.

Quotations should be single-spacing. The typeface will be Times at a font of 10 points.

Notes (Times, 10 points) should be numbered consecutively and placed as footnotes. They should be cited in the manuscript by superscript Arabic numbers. If using an acknowledgment note, it should appear on the cover sheet of the manuscript. For the purposes of peer review, please mark this note with an asterisk and start your substantive notes numbering with "1" in the main text of the manuscript.

Book reviews may not contain footnotes.

References should be arranged in alphabetical order and place at the end of the text.

Every publication listed in the reference list must be mentioned in the text or notes.

References are indicated in text using the author/date style of references, e.g.:

Book: Durkheim É., 1979 [1912], *Les formes élémentaires de la vie religieuse*, Paris, PUF, 6^e édition.

Journal article: Boudon R., 2006, « Bonne et mauvaise abstraction », *L'Année sociologique*, vol. 56, n°2, 263-284.

We request that authors supply inclusive page numbers for book chapters.

To aid typesetting, please indicate the following markup to identify: title, markup <TITLE> ; the first paragraph of the article, markup <TEXT> ; heading, level 1, markup < IT1> ; heading level 2: markup < IT2 > ; bibliography, markup <BIBLIOGRAPHY> ; author's signature, markup <SIGNATURE>.
